This bill increases the amount appropriated to the Elections Commission by \$304,100 in each year of the 2017-19 biennium in order to increase the number of FTE positions authorized to the Elections Commission by 5.0 FTE positions.

**SECTION 1. Fiscal changes.**

(1) ELECTIONS COMMISSION; FEDERAL FUNDING FOR ELECTION<sup>S</sup> ADMINISTRATION. In the schedule under section 20.005 (3) of the statutes for the appropriation to the elections commission under section 20.510 (1) (x) of the statutes, the dollar amount for fiscal year 2017-18 is increased by \$304,100 to increase the authorized FTE positions for the elections commission by 5.0 FTE FED positions during fiscal year 2017-18 for the purpose of elections administration.
