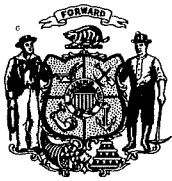
Hello,

5 of the wolf population in this state or that prohibits the killing of wolves in this
6 state.”.

7 ✓ 2. Page 3, line 5: delete lines 5 and 6 and substitute:

8 “2. Except as provided in par. (d), take any action to inform or support federal
9 law enforcement officers regarding the enforcement of any federal or state law
10 relating to wolves.”

11 3. Page 3, line 6: after that line insert:

1 “(d) If a law enforcement officer knows of, or has evidence of, an action that has
2 occurred or is occurring that violates a federal law relating^{to} wolves, the law
3 enforcement officer shall notify and provide all evidence of the violation to federal
4 law enforcement.”
