BB Under current law, beginning in the 2018-19 school year, *DPI* must make payments to school districts, independent charter schools, and private schools participating in a parental choice program that increased the amount the school district, independent charter school, or private school spent to employ, hire, or retain social workers over the amount spent by the school district, independent charter school, or *over* private school to employ, hire, or retain social workers in the immediately preceding school year. Under the bill, DPI must make these payments to school districts, independent charter schools, and private schools participating in a parental choice program that increase spending on school counselors, school social workers, school psychologists, and school nurses. The bill also increases the funding for this categorical aid by \$17,000,000 in the 2018-19 school year.

3 SECTION 1. 115.364 (1) (a), (am), and (b) of the statutes, as created by 2017

 2 with one of the entities under s. 118.40 (2r) (b) 1. or with the director under s. 118.40
 3 (2x) that increased the amount it expended in the preceding school year to employ,
 ④ hire, or retain ~~social workers~~ ^{pupil services personnel} over the amount it expended in the school year
 5 immediately preceding the preceding school year to employ, hire, or retain social
 6 workers pupil services personnel.

7 (am) "Eligible private school" means a private school participating in a
 8 parental choice program under s. 118.60 or 119.23 that increased the amount it
 ⑨ expended in the preceding school year to employ, hire, or retain ~~social workers~~ ^{pupil services personnel} over
 10 the amount it expended in the school year immediately preceding the preceding
 11 school year to employ, hire, or retain ~~social workers~~ pupil services personnel.

12 (b) "Eligible school district" is a school district that increased the amount it
 ⑬ expended in the preceding school year to employ, hire, or retain ~~social workers~~ ^{pupil services personnel} over
 14 the amount it expended in the school year immediately preceding the preceding
 15 school year to employ, hire, or retain ~~social workers~~ pupil services personnel.
