The governor's executive budget fully funded DPI's mental health request, including \$200,000/yr (400/biennial) for SBIRT expansion. In our bill, we had only put \$100,000/yr (200/biennial) in the special session bill based on the GPR designated for our project. We would like to amend the special session bill to double the amount and keep it the same as the governor's budget proposal.
