Analysis by the Legislative Reference Bureau

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 15.107 (19) of the statutes is created to read:

15.107 (19) Interagency council on homelessness, attached to the department of administration under s. 15.03. The council shall appoint a director, to serve at the pleasure of the council, who shall be known as the state director to prevent and end homelessness. The director shall coordinate the activities of the council and partner organizations. The council shall meet quarterly and may meet at other times on the call of the

1	chairperson or a majority of its members. The council shall consist of the following
2	members:
3	(a) The governor, or his or her designee, who shall serve as chairperson.
4	(b) The secretary of administration, or his or her designee.
5	(c) The executive director of the Wisconsin Housing and Economic
6	Development Authority, or his or her designee.
7	(d) The secretary of health services, or his or her designee.
8	(e) The secretary of children and families, or his or her designee.
9	(f) The secretary of workforce development, or his or her designee.
10	(g) The secretary of veterans affairs, or his or her designee.
11	(h) The secretary of corrections, or his or her designee.
12	(i) The state superintendent of public instruction, or his or her designee.
13	(j) One representative from each of the following organizations:
14	1. Wisconsin Balance of State Continuum of Care, Inc., or its successor.
15	2. Milwaukee Continuum of Care, or its successor.
16	3. Continuum of Care for the City and County of Racine, U.A., or its successor.
17	4. Homeless Services Consortium of Dane County, or its successor.
18	Section 2. 16.03 of the statutes is created to read:
19	16.03 Interagency council on homelessness. (1) Definitions. In this
20	section:
21	(a) "Council" means the interagency council on homelessness.
22	(b) "State agency" means each agency specified under s. 15.107 (19) (b) to (i).
23	(2) RESPONSIBILITIES. The council shall do all of the following:
24	(a) Establish and periodically review a statewide policy with the purpose of
25	preventing and ending homelessness in this state.

(b) Designate individuals from each agency or organiz	zation represe	ented on the
council, who shall meet at least twice quarterly, to coordina	te the impler	nentation of
policy established by the council under par. (a).		
(c) Submit a report on the activities of the council to	the governo	r and to the
chief clerk of each house of the legislature, for distribu	ition to the	appropriate
standing committees under s. 13.172 (3). The council shall	determine th	e frequency
of the report and schedule for submitting the report, but m	nay not submi	t the report
less frequently than annually.		
(3) State agencies shall cooperate with the council an	ıd individuals	designated
under sub. (2) (b) in the implementation of the policy estab	olished under	sub. (2) (a).
