We would like to have three amendments drafted to AB 234, which the Joint Committee on Finance is taking up on Monday. I apologize for the short notice! Since the committee is meeting at 1:30, we would like the amendments by 12:00 if at all possible.

The three amendments are as follows:

1. Authorize the Interagency Council on Homelessness to make budget recommendations for the 2019-21 biennial budget and future biennial budgets.
2. Add four additional members to the Council who are representatives of the Wisconsin Balance of State Continuum of Care. Specify that those members come from the following four geographic regions: Green Bay, Fox Valley, La Crosse, and Eau Claire/Superior.
3. Combine Amendments #1 and #2 into a third amendment.

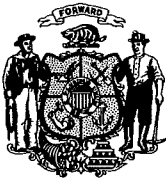
