1 At the locations indicated, amend the bill as follows:

2 1. Page <sup>22 24</sup> 20, line 19: delete "(4)" and substitute "(4) (a)".

3 2. Page <sup>23 4</sup> 20, line 24: after that line insert:

4 "(b) The service of a nonunanimous settlement agreement under par. (a) may  
5 not serve as a substitute for the standard filings required by the commission in  
6 dockets wherein the applicant seeks an order regarding the reasonableness of its  
7 rates. This requirement may be waived by the commission for good cause shown."

8 3. Page <sup>23 10</sup> 21, line 6: delete "settlement agreement under sub. (4)" and substitute  
9 "unanimous settlement agreement or 60 days of service of a nonunanimous  
10 settlement agreement under sub. (4) (a)".

11 4. Page <sup>23 13</sup> 21, line 9: delete "30 days of service" and substitute "30 or 60 days of  
12 service, as applicable".
