2	1. Page 1, line delete the material beginning with that line and ending on
3	page 2, line 7, and substitute:
4	"Section 1m. 30.69 (1) (a) of the statutes is amended to read:
5	30.69 (1) (a) Except as provided in par. pars. (ag) and (b), no person may operate
6	a motorboat towing a person on water skis, aquaplane, or similar device unless there
7	is in the boat motorboat a competent person in addition to the operator in a position
8	to observe the progress of the person being towed. An observer shall be considered
9	competent if that person can in fact observe the person being towed and relay any
10	signals to the operator.
11	(ag) This The observer requirement under par. (a) does not apply to meterboats
12	any of the following:

L	1. An operator of a motorboat classified as a Class A motorboats motorboat by
