# 2017 SENATE BILL 135

1	AN ACT to amend 343.31 (3) (a), 343.38 (1) (intro.), 343.38 (1) (c) 1., 343.44 (2)
2	(ar) 2. and 343.44 (2p) (intro.); and <i>to create</i> 343.31 (1m), 343.38 (1) (d) and
3	343.44 (2) (ar) 2m. of the statutes; <b>relating to:</b> revocation of operating privilege
4	for certain offenses related to operating while intoxicated, operating after
5	revocation, making an appropriation, and providing a criminal penalty.

#### Analysis by the Legislative Reference Bureau

# The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

6 SECTION 1. 343.31 (1m) of the statutes is created to read:
7 343.31 (1m) (a) In this subsection, "qualifying conviction" means any of the
8 following:
9 1. A conviction for a violation under s. 940.06, 940.09, or 940.10 involving the
10 use of a vehicle.

2. A conviction for a crime punishable as a felony under chs. 341 to 348 or a
 felony in the commission of which a motor vehicle is used.

3 (b) If the number of convictions under ss. 940.09 (1) and 940.25 in the person's 4 lifetime, plus the total number of other convictions, suspensions, and revocations 5 counted under s. 343.307 (1), equals 4 or more, and the 4th conviction, suspension, 6 or revocation occurs within 15 years of the previous conviction, suspension, or 7 revocation, the department shall revoke the person's operating privilege 8 permanently. The person is not eligible for an occupational license under s. 343.10. 9 After 10 years of the revocation period have elapsed, the person may apply for 10 reinstatement under s. 343.38.

(c) If the number of convictions under ss. 940.09 (1) and 940.25 in the person's
lifetime, plus the total number of other convictions, suspensions, and revocations
counted under s. 343.307 (1) within a 25-year period, equals 2 or more, and the
person has 2 or more qualifying convictions, the department shall revoke the person's
operating privilege permanently. The person is not eligible for an occupational
license under s. 343.10. After 10 years of the revocation period have elapsed, the
person may apply for reinstatement under s. 343.38.

**SECTION 2.** 343.31 (3) (a) of the statutes is amended to read:

343.31 (3) (a) Except as otherwise provided in this subsection or sub. (1m),
(2m), (2s), (2t), or (2x), all revocations or suspensions under this section shall be for
a period of one year.

22 SECTION 3. 343.38 (1) (intro.) of the statutes is amended to read:

23 343.38 (1) REINSTATEMENT AFTER REVOCATION. (intro.) Except as provided in ss.
24 343.10, <u>343.31 (1m)</u>, 343.39, and 351.07, the department shall not reinstate the

18	2. Not more than 45 days before applying for reinstatement, the person submits
19	to and complies with an assessment by an approved public treatment facility, as
20	defined in s. 51.45 $(2)$ (c), for examination of the person's use of alcohol, controlled
21	substances, or controlled substance analogs and development of a driver safety plan
22	for the person.
23	<b>SECTION 6.</b> 343.44 (2) (ar) 2. of the statutes is amended to read:

3	<b>SECTION 7.</b> 343.44 (2) (ar) 2m. of the statutes is created to read:
4	343.44 (2) (ar) 2m. Except as provided in subds. 3. and 4., any person who
5	violates sub. (1) (b) shall be fined not more than $10,000$ or imprisoned for not more
6	than one year or both if the revocation identified under sub. (1) (b) is under s. $343.31$
7	(1m) and the person has been previously convicted of a violation of sub. $(1)$ (b) where
8	the revocation identified under sub. (1) (b) was under s. $343.31$ (1m).
9	SECTION 8. 343.44 (2p) (intro.) of the statutes is amended to read:
10	343.44 (2p) SENTENCING OPTION. (intro.) The legislature intends that courts use
11	the sentencing option under s. 973.03 (4) whenever appropriate for persons subject
12	to sub. (2) to provide cost savings for the state and for local governments. This option
13	shall not be used if the <u>revocation is a permanent revocation under s. 343.31 (1m) or</u>
14	<u>if the</u> suspension or revocation was for one of the following:
15	SECTION 9. Nonstatutory provisions.
16	(1) Notwithstanding section 16.42 $(1)$ (e) of the statutes, if this subsection takes
17	effect in fiscal year 2018-19, in submitting information under section 16.42 of the
18	statutes for purposes of the 2019-21 biennial budget bill, the department of
19	transportation shall submit information concerning the appropriation under section
20	20.395 (5) (cq) of the statutes as though the increase in the dollar amount of that
21	appropriation by SECTION 10 (1) of this act had not been made.

### SECTION 11. Initial applicability.

4 (1) This act first applies to violations committed on the effective date of this 5 subsection, but does not preclude the counting of other convictions, suspensions, or 6 revocations as prior convictions, suspensions, or revocations for purposes of 7 administrative action by the department of transportation.

8 **SECTION 12. Effective dates.** This act takes effect on the first day of the 9th 9 month beginning after publication, except as follows:
