1 **AN ACT** *to renumber and amend* 446.02 (7) (a), 446.02 (7) (d) 1. and 446.02 (7)
2 (d) 2.; *to amend* 441.001 (3) (a), 441.001 (4) (b) and 446.026 (1) (a); and *to*
3 **create** 446.01 (1v), 446.02 (7) (a) 2. and 446.02 (10m) of the statutes; **relating**
4 **to:** performance of medical examinations by chiropractors for the Federal
5 Motor Carrier Safety Administration; delegation of certain services by a
6 chiropractor; and modifying various administrative rules promulgated by the
7 Chiropractic Examining Board.

Analysis by the Legislative Reference Bureau

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

8 **SECTION 7.** 441.001 (3) (a) of the statutes is amended to read:
9 441.001 (3) (a) “Practical nursing” means the performance for compensation
10 of any simple acts in the care of convalescent, subacutely or chronically ill, injured

1 or infirm persons, or of any act or procedure in the care of the more acutely ill, injured
2 or infirm under the specific direction of a nurse, physician, podiatrist licensed under
3 ch. 448, chiropractor licensed under ch. 446, dentist licensed under ch. 447 or
4 optometrist licensed under ch. 449, or under an order of a person who is licensed to
5 practice medicine, podiatry, chiropractic, dentistry or optometry in another state if
6 that person prepared the order after examining the patient in that other state and
7 directs that the order be carried out in this state.

9 441.001 (4) (b) The execution of procedures and techniques in the treatment
10 of the sick under the general or special supervision or direction of a physician,
11 podiatrist licensed under ch. 448, chiropractor licensed under ch. 446, dentist
12 licensed under ch. 447, or optometrist licensed under ch. 449, or under an order of
13 a person who is licensed to practice medicine, podiatry, chiropractic, dentistry, or
14 optometry in another state if the person making the order prepared the order after
15 examining the patient in that other state and directs that the order be carried out
16 in this state.
