2017 SENATE BILL 494

1 **AN ACT** *to repeal* 115.385 (1m); and *to amend* 115.28 (10m) (a) (intro.), 115.28
2 (10m) (b), 115.28 (10o) (a) and 115.385 (1) (intro.) of the statutes; **relating to:**
3 publication of school and school district accountability reports.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 **SECTION 1.** 115.28 (10m) (a) (intro.) of the statutes is amended to read:
5 115.28 **(10m)** (a) (intro.) ~~By October 15, 2015, and annually thereafter~~
6 Annually by November 30, submit to the commissioner of the opportunity schools
7 and partnership program under subch. II of ch. 119 and to the superintendent of
8 schools of the school district operating under ch. 119 a report that identifies the
9 schools in Milwaukee County and located in a school district that was placed in the
10 lowest performance category on the most recent accountability report published for

4 **SECTION 2.** 115.28 (10m) (b) of the statutes is amended to read:

5 115.28 (10m) (b) By ~~October 15~~ November 30 of the first year in which the state
6 superintendent determines that a school district is an eligible school district, as
7 defined in s. 115.999 (1) (d), and annually thereafter, submit to the commissioner of
8 the opportunity schools and partnership program under subch. IX a report that
9 identifies each school in that eligible school district that was assigned to the lowest
10 performance category on the most recent accountability report published for the
11 school under s. 115.385 (1) and that disaggregates the schools by elementary school,
12 middle school, junior high school, high school, and senior high school.

13 **SECTION 3.** 115.28 (10o) (a) of the statutes is amended to read:

14 115.28 (10o) (a) ~~Beginning in October of the 2015-16 school year, annually~~
15 Annually by November 30, determine whether any school district qualifies as an
16 eligible school district, as defined in s. 115.999 (1) (d).

17 **SECTION 4.** 115.385 (1) (intro.) of the statutes is amended to read:

18 115.385 (1) (intro.) ~~Subject to sub. (1m), annually~~ Annually by September
19 November 30, the department shall publish a school and school district
20 accountability report that includes all of the following components:

21 **SECTION 5.** 115.385 (1m) of the statutes is repealed.
