ASSEMBLY SUBSTITUTE AMENDMENT ,  
TO SENATE BILL 337

1 AN ACT *to create* 16.42 (1) (f), 16.423 and 16.46 (5g) of the statutes; **relating to:**  
2 submission of base budget review reports by state agencies, the legislature, and  
3 the courts.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

4 SECTION 1. 16.42 (1) (f) of the statutes is created to read:

5 16.42 (1) (f) The information required under s. 16.423.

6 SECTION 2. 16.423 of the statutes is created to read:

7 **16.423 Base budget review reports.** (1) In this section, "state agency" has  
8 the meaning given in s. 20.001 (1).

9 (2) (a) During the 2017-19 fiscal biennium, the secretary shall require that all  
10 state agencies submit a report no later than September 15, 2018, and then no later  
11 than May 15 in the even-numbered year in every biennium thereafter, that contains  
12 the information specified in sub. (3).

1 (b) Beginning in the 2019-21 fiscal biennium, the secretary shall require that  
2 any state agency created after May 15, 2018, submit a report no later than the May  
3 15 in the even-numbered year that first occurs after the state agency is created, and  
4 then no later than May 15 in the even-numbered year in every biennium thereafter,  
5 that contains the information specified in sub. (3).

6 (3) A report submitted under this section shall contain at least all of the  
7 following:

8 (a) A description of each appropriation of the state agency.

9 (b) For each appropriation of the state agency, an accounting of all expenditures  
10 in every quarter in each of the prior 3 fiscal years.

11 (c) For each appropriation of the state agency, an analysis of whether the  
12 appropriation contributes to the mission of the agency and whether the objectives of  
13 the appropriation justify its expenditures.

14 (d) For each appropriation of the state agency, a determination of the minimum  
15 level of funding to achieve its objectives *(but not to exceed the prior fiscal*  
*year's* and an accounting of its current funding. *base*

16 (e) A description of the state agency mission or guiding principles. If a state *funding,*  
17 agency does not have an agency mission or guiding principles, the state agency shall  
18 adopt an agency mission or guiding principles and describe the mission or principles  
19 in the report.

20 (3m) A report filed under this section shall be in a form that is consistent with  
21 the form used by a state agency that filed a base budget review report under s. 16.423,  
22 2007 stats.

23 SECTION 3. 16.46 (5g) of the statutes is created to read:
