## **2017 ASSEMBLY BILL 786**

AN ACT to renumber and amend 165.967; to create 165.967 (2) of the statutes; and to affect 2015 Wisconsin Act 55, section 763qb, 2015 Wisconsin Act 55, section 9426 (1q) and 2017 Wisconsin Act 59, sections 2265p and 9428 (1r) (b); relating to: the Court Appointed Special Advocates grant program and making an appropriation.

## The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- 6 SECTION 1. 165.967 of the statutes is renumbered 165.967 (1) and amended to 7 read:

  9 justice shall in each fiscal year provide \$80,000 \$250,000 to the Wisconsin Court

15	by \$250,000 for the purposes of the Court Appointed Special Advocates grant
16	program under section 165.967 of the statutes. In the schedule under section $20.005$
17	(3) of the statutes for the appropriation to the department of justice under section
18	20.455 (5) (es) of the statutes, the dollar amount for fiscal year 2018–19 is increased
19	by \$250,000 for the purposes of the Court Appointed Special Advocates grant
20	program under section 165.967 of the statutes.
