Analysis by the Legislative Reference Bureau

This bill authorizes the governor, during a state of emergency declared by the governor, to waive any fee required by the state for the replacement of a permit, license, approval, or other authorization for a person who resides or is headquartered in the area covered by the state of emergency.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- **Section 1.** 323.12 (4) (e) of the statutes is created to read:
- 323.12 (4) (e) At his or her discretion, waive any fee required by the state for the replacement of a permit, license, approval, or other authorization for a person who resides or is headquartered in the area to which the governor's executive order
