# The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

**SECTION 1.** 346.02 (10) of the statutes is amended to read:

346.02 (10) APPLICABILITY TO SNOWMOBILES. The operator of a snowmobile upon a roadway shall in addition to the provisions of ch. 350 be subject to ss. 346.04, 346.06, 346.11, 346.14 (1) (1m), 346.18, 346.19, 346.20, 346.21, 346.215 (3), 346.26, 346.27, 346.33, 346.35, 346.37, 346.39, 346.40, 346.44, 346.46, 346.47, 346.48, 346.50 (1) (b), 346.51, 346.52, 346.53, 346.54, 346.55, 346.87, 346.88, 346.89, 346.90, 346.91, 346.92 (1) and 346.94 (1) and (9).

### **SENATE BILL 695**

<b>Section 2.</b> 346.02 (11) of the statutes is amended to read:
346.02 (11) Applicability to all-terrain vehicles and utility terrain
VEHICLES. The operator of an all-terrain vehicle or a utility terrain vehicle on a
roadway is subject to ss. 346.04, 346.06, 346.11, 346.14 (1) (1m), 346.18, 346.19,
346.20, 346.21, 346.215 (3), 346.26, 346.27, 346.33, 346.35, 346.37, 346.39, 346.40, 346.21, 346
346.44, 346.46, 346.47, 346.48, 346.50 (1) (b), 346.51, 346.52, 346.53, 346.54, 346.55,
346.71, 346.87, 346.88, 346.89, 346.90, 346.91, 346.92 (1) and 346.94 (1) and (9) but
is not subject to any other provision of this chapter.
<b>Section 3.</b> 346.14 (1) of the statutes is renumbered 346.14 (1m).
<b>Section 4.</b> 346.14 (1b) of the statutes is created to read:
346.14 (1b) In this section, "platoon" means a group of individual motor
vehicles traveling in a unified manner at electronically coordinated speeds.
<b>Section 5.</b> 346.14 (2) (c) of the statutes is created to read:
346.14 (2) (c) This subsection does not apply to an operator of vehicle in a
platoon other than the lead vehicle.
