All,

Thank you all for your attention to Assembly Amendment to ASA 2 (LRBa1999/P1) to AB 805/SB 677.

There appears to be an incorrect reference in Assembly Amendment to ASA 2 (LRBa1999/P1) on page 2 lines 7-8. We believe those lines should read, "approved to provide the instruction by the participating ~~private, nonprofit institution~~ University of Wisconsin System institution or a faculty member of the participating ~~private, nonprofit institution~~ University of Wisconsin System institution".

This mirrors lines 7-8 on page 1 of LRBa1999/P1, since these sections refer to agreements und subd. 1. a., which references "the chancellor of a University of Wisconsin System institution" earlier in the sub amendment. The other sections referring to subd. 1. b. are correct since they refer to "the president of a private, nonprofit institution."
