Assumptions Used in Arriving at Fiscal Estimate

Additional training would be needed for field staff and individuals who work with driver records, totaling approximately 475 personnel. This training can be incorporated in existing periodic training at no cost.

The total IT development effort involved in addressing the requirements of this bill would cost approximately \$157,000 and take approximately 6 months to complete. This bill provides an implementation window that accommodates this time frame.

This bill changes the driver license and identification card (DL/ID) application forms and requires that the new form be utilized. The current stock of application forms (approximately one year's worth) would need to be destroyed and replaced, costing \$14,700.

There were approximately 1,221,000 DL/ID transactions done in customer service centers in 2016. The changes made to the application form by this bill would add approximately 12 seconds to each of these transactions. This increase would add approximately 0.5 FTE of work annually, costing approximately \$26,200.

Long-Range Fiscal Implications

This bill would add approximately 0.5 FTE of work annually, costing approximately \$26,200.
