LRB 1418 ensures that volunteer health providers who serve the homeless in free and charitable clinics are covered by the state's liability insurance program.

The Volunteer Health Care Program (VHCP) provides liability insurance for licensed health professionals who volunteer their services to provide outpatient care at free clinics. Eligibility is determined by the percent of individuals served in the clinic who are uninsured or underinsured who are not Medicaid recipients.

Unfortunately, this definition excludes the free and charitable clinics who provide services to our state's homeless population. Generally, homeless individuals in Wisconsin are enrolled in Medicaid. As such, when free and charitable clinics serve this population, their doctors are no longer eligible for the Volunteer Health Care Program.

LRB 1418 alters the eligibility for the VHCP so that providers who serve the homeless in free and charitable clinics can still maintain their liability insurance through the state.

It's crucial for us to continue our commitment to reduce and eliminate homelessness in Wisconsin. This bill removes a serious barrier to treatment by ensuring that volunteer health professionals do not lose their liability insurance by treating the homeless in free clinics.
