Joseph, Please discard a0448, and replace with the following language: as before, the function here is the same, just trying to make the language as clear as possible.

**SECTION 1. 77.54 (69)** of the statutes is created to read:

477.54 (69) (a) The sales price from the sale of and the use or other consumption of precious metal bullion. For purposes of this subsection, "precious metal bullion" means coins, bars, or rounds, that contain gold, silver, copper, platinum, or palladium and that are marked with weight, purity, and content or for which a government authority has minted based on weight, purity, and content.
