Hi Fern,

Could we amend several things in this bill:

- -Section 3- after 'enters into a whole grade sharing agreement' add a line that reads 'participates in that whole grade sharing agreement'. There were some concerns brought up that there is a scenario where schools enter into an agreement but it falls apart or they don't go through with it, so we wanted to clarify.
- -Change references to the 2019-20 school year to the 2020-21 school year
- -Change the appropriation timeline as well to reflect that
- -Leg Council pointed out that current statutes read that school districts must enter into a whole grade sharing agreement by Feb. 15th and would the schools have enough time to apply based on when this bill was passed/signed/etc. so would it be possible for us to extend the Feb. 15th deadline to May 1st just for the inaugural year of this aid? The deadline after that would still be Feb. 15th. Is this something we could do?
