Hi Konrad,

I'm writing to request another preliminary draft for Rep. Ballweg. This one is very similar to what you drafted in LRB-3872/P1.

Specifically, this bill should require Office of Suicide Prevention in DHS to award grants in the total amount of [\$-] on a one-time basis to an organization or a coalition of organizations (which may include a county, city, village, or town) for any of the following activities:

- Sharing guidelines and training staff at a firearm retailer or firearm range on how to avoid selling or renting a firearm to an individual who may be considering suicide;
- Providing materials relating to suicide prevention for distribution at a firearm retailer or firearm range; or
- Providing voluntary firearm storage.

Rep. Ballweg is still working on determining the amount of funds that should be appropriated and whether a new appropriation should be created or an existing DHS appropriation should be increased. For now, please draft the bill as though a new appropriation is created for this grant program. Please insert a "\$-" or similar placeholder wherever the dollar amount will be inserted when that number is determined. Additionally, for now, do not specify a special effective date. Thanks!

Good afternoon, Konrad.

I am writing to request some modifications to several of the existing bill drafts for the Suicide Prevention Task Force.

LRB-3871/P1

- Delete language on page 2 placing the office in the division that manages care and treatment services related to mental health, substance use, and developmental disabilities. Rather, this bill draft should simply provide that the office is created in DHS.
- Add to the list of duties of the office that it will administer grant programs. Add to the list of duties of the director that the director administer the grant programs created by LRB-3872, LRB-4241, and LRB-4246 and will report to the Legislature as required under LRB-4246.
- Create a new appropriation to fund the office with \$250,000 per year and authorize 2 FTE.

LRB-3872/P2

- Modify this draft to create a new, standalone biennial appropriation funded with \$250,000 per each fiscal year of the biennium.
- Require that the grants be distributed by DHS (without reference to the office of suicide prevention).
- Limit the total grant amount per recipient in one year to no more than \$10,000.
- Require that a grant recipient provide a 20% match, in cash or in-kind services.
- On page 2, delete “measures that reduce access to lethal means of self-harm and for” and replace that with “marketing suicide prevention resources, sponsoring local culturally competent trainings, and”

LRB-4241/P1

- Modify this draft to create a new, standalone biennial appropriation funded with \$75,000 per each fiscal year of the biennium.
- Require that the grants be distributed by DHS (without reference to the office of suicide prevention).
- Limit the total grant amount per recipient in one year to no more than \$5,000.
- Require that a grant recipient provide a 20% match, in cash or in-kind services.
- Provide that the grant cannot be renewed; rather, a recipient must apply for a new grant each year and DHS must give preference in awarding grants to organizations or coalitions of organizations that have not yet received a grant under this program.

There may be a few more modifications coming soon, but hopefully we are getting close. Please feel free to call if you have any questions.
