Not sure if this request is best directed to you or one of your colleagues; my apologies if I guessed wrong!

Please write Rep. Katsma a P1 bill draft that provides that debit cards may be used for the purchase of lottery tickets. Some folks suggested that this might be achieved with words such as:

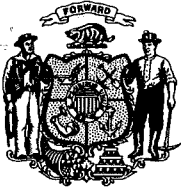
565.17(3) Cash or debit card sales. Lottery tickets or lottery shares may be sold only for cash or by debit card. Payment by credit cards, charge cards, or any similar form of deferred payment is prohibited.

For time management purposes: there is some chance that we would want to incorporate this in the DOR—Lottery Administration piece of the budget within the next few weeks. But I do not presently expect this budget topic to come up in JFC in the next 10 days.
