Hi Fern,

This looks great! Thank you.

We need to delete Section 1 & Section 2 from the amendment.

For the top note on page 2 of the amendment, yes, we would like the information to include whether the child participated in the program and also whether or not the child successfully completed the program.

DPI stated in its written testimony that the bill currently requires the DPI to select three urban and three rural school districts to be part of this pilot program. The bill does not specify any criteria on which the Department may base that selection.

-For this, we would like to have DPI choose districts with largest achievement gaps. We want to automatically include Milwaukee (a school district within a first-class city), and we would like to include two urban districts with the largest achievement gaps and three rural districts with the largest achievement gaps.

-In looking at urban and rural, can we use population size characteristics to determine urban and rural.

Also, on page 3 of the bill, line 4, can we include in the criteria that the program is already established/in place. We want to ensure that the program used is already in place and being used in other states.



Can we get this all as a /P2 amendment?
