## ASSEMBLY AMENDMENT 2, TO ASSEMBLY BILL 806

February 11, 2020 – Offered by Representatives Goyke, Crowley, Hintz, Hesselbein, Spreitzer, Doyle, B. Meyers, McGuire, Neubauer, Fields, Pope, Ohnstad, Sargent, Subeck, Sinicki, C. Taylor, Vining, Emerson, Cabrera, Bowen, Brostoff and Stuck.

1 At the locations indicated, amend the bill as follows:

- 2 **1.** Page 1, line 2: before "acts" insert "Authorized State Building Program changes,".
- 2. Page 1, line 3: delete "Program" and substitute "Program, granting bonding authority, and making an appropriation".
  - **3.** Page 2, line 1: before that line insert:
- 7 "Section 1d. 13.48 (27m) (ba) of the statutes is created to read:
- 8 13.48 **(27m)** (ba) The building commission may authorize up to a total of \$30,957,000 in additional general fund supported borrowing for grants under par.
- 10 (b).

- **SECTION 1h.** 20.410 (3) (fn) of the statutes is created to read:
- 12 20.410 (3) (fn) Secured residential care centers for children and youth; 13 supplemental funding. A sum sufficient to reimburse s. 20.866 (1) (u) for the

payment of principal and interest costs incurred as supplemental funding under s. 13.48 (27m) (ba) for the design and construction of secured residential care centers for children and youth and attached juvenile detention facilities as specified in s. 13.48 (27m), to make the payments determined by the building commission under s. 13.488 (1) (m) that are attributable to the proceeds of obligations incurred in financing those projects, and to make payments under an agreement or ancillary arrangement entered into under s. 18.06 (8) (a).

**SECTION 1p.** 20.866 (1) (u) of the statutes, as affected by 2019 Wisconsin Act 9, is amended to read:

20.866 (1) (u) *Principal repayment and interest.* A sum sufficient from moneys appropriated under sub. (2) (zp) and ss. 20.115 (2) (d) and (7) (b) and (s), 20.190 (1) (c), (d), (i), and (j), 20.225 (1) (c) and (i), 20.245 (1) (e) and (j), 20.250 (1) (c) and (e), 20.255 (1) (d), 20.285 (1) (d), (gj), and (je), 20.320 (1) (c) and (t) and (2) (c), 20.370 (7) (aa), (ad), (aq), (ar), (at), (au), (bq), (br), (cb), (cc), (cd), (cg), (cq), (cr), (cs), (ct), (ea), (eq), and (er), 20.395 (6) (af), (aq), (ar), and (au), 20.410 (1) (e), (ec), and (ko) and (3) (e) and, (fm), and (fn), 20.435 (2) (ee), 20.465 (1) (d), 20.485 (1) (f) and (go) and (4) (qm), 20.505 (4) (es), (et), (ha), and (hb) and (5) (c), (g), and (kc), 20.855 (8) (a), and 20.867 (1) (a) and (b) and (3) (a), (b), (bb), (bc), (bd), (be), (bf), (bg), (bh), (bj), (bL), (bm), (bn), (bq), (br), (bt), (bu), (bw), (bx), (cb), (cd), (cf), (ch), (cj), (cq), (cr), (cs), (cw), (cx), (g), (h), (i), (kd), and (q) for the payment of principal, interest, premium due, if any, and payment due, if any, under an agreement or ancillary arrangement entered into under s. 18.06 (8) (a) relating to any public debt contracted under subchs. I and IV of ch. 18.

**Section 1r.** 20.866 (2) (uz) of the statutes is amended to read:

20.866 **(2)** (uz) *Corrections; juvenile correctional facilities*. From the capital improvement fund, a sum sufficient for the department of corrections to acquire, construct, develop, enlarge or improve juvenile correctional facilities. The state may contract public debt in an amount not to exceed \$28,652,200 \$73,150,400 for this purpose.

**SECTION 1t.** 20.866 (2) (uzc) of the statutes, as affected by 2019 Wisconsin Act 9, is amended to read:

20.866 (2) (uzc) Secured residential care centers for children and youth. From the capital improvement fund, a sum sufficient for the department of corrections to provide grants to counties for designing and constructing secured residential care centers for children and youth and attached juvenile detention facilities as specified in s. 13.48 (27m). The state may contract public debt in an amount not to exceed \$40,000,000 for this purpose. The state may contract additional public debt in an amount up to \$40,000,000 \$70,957,000 for this purpose.

**Section 1v.** 20.866 (2) (v) of the statutes, as affected by 2019 Wisconsin Act 9, is amended to read:

20.866 (2) (v) Health services; mental health and secure treatment facilities. From the capital improvement fund, a sum sufficient for the department of health services to acquire, construct, develop, enlarge, or extend mental health and secure treatment facilities. The state may contract public debt in an amount not to exceed \$223,646,200 for this purpose. The state may contract additional public debt in an amount up to \$74,782,900 \$89,782,900 for this purpose.".

**4.** Page 2, line 14: after that line insert:

"Section 2e. 2017 Wisconsin Act 185, section 110 (4) (f), as last affected by 2019 Wisconsin Act 8, is repealed.

**SECTION 2f.** 2017 Wisconsin Act 185, section 110 (7), as last affected by 2019 Wisconsin Act 8, is amended to read:

[2017 Wisconsin Act 185] Section 110 (7) Type 1 Juvenile Correctional Facilities. The department of corrections shall establish or construct the Type 1 juvenile correctional facilities under section 301.16 (1w) (a) of the statutes no later than July 1, 2021, subject to the approval of the joint committee on finance. The department shall consider the recommendations of the juvenile corrections study committee under subsection (6) (c) 2. in establishing or constructing these facilities.

**Section 2g.** 2017 Wisconsin Act 185, section 110 (7g) is amended to read:

[2017 Wisconsin Act 185] Section 110 (7g) Mendota Juvenile treatment center. The department of health services shall construct an expansion of the Mendota juvenile treatment center to accommodate no fewer than 29 additional juveniles, subject to the approval of the joint committee on finance.

## Section 2j. Nonstatutory provisions.

- (1) County residential care centers for Children and Youth. In 2017 Wisconsin Act 59, section 9104 (1) (c) 1. ev., as created by 2019 Wisconsin Act 9, under projects financed by general fund supported borrowing, the amount authorized for the project identified as "County Secured Residential Care Centers for Children and Youth" is increased from \$80,000,000 to \$110,957,000 and the appropriate totals are adjusted accordingly.
- (2) Type 1 Juvenile Correctional facilities. In 2017 Wisconsin Act 59, section 9104 (1) (c) 1. em., as created by 2017 Wisconsin Act 185, under projects financed by general fund supported borrowing, the amount authorized for the project identified

- 1 as "Type 1 juvenile correctional facilities statewide" is increased from \$25,000,000
- 2 to \$73,150,400 and the appropriate totals are adjusted accordingly.".
