AN ACT ...; relating to: authorizing certain overseas and military voters to vote

absentee by electronic transmission and granting rule-making authority.

Analysis by the Legislative Reference Bureau

This bill requires the Elections Commission to promulgate rules authorizing overseas voters who are service members or civilian employees of or independent contractors with the U.S. Department of Defense to vote absentee by electronic transmission. Under current law, such voters must return their absentee ballots by mail.

The commission's rules must include all of the following requirements:

- 1. The elector has a valid federal common access card (CAC). The CAC is a "smart" card used as a standard identification for active duty uniformed service personnel, civilian employees of DOD, and eligible DOD contractor personnel.
- $2.\ A$ voter may vote absentee by electronic transmission only if the voter waives the right to a secret ballot.
- 3. When an absentee ballot is received by electronic transmission, the person receiving the transmission must examine it to determine that all pages have been received and are legible and may not reveal how the voter voted.
- 4. The absentee ballot must be sealed in an envelope marked with the voter's name and stored with other returned absentee ballots.

The elector shall then affix sufficient postage unless the absentee ballot qualifies for mailing free of postage under federal free postage laws and shall mail the absentee ballot to the municipal clerk. Except as authorized in s. 6.97 (2) or in rules promulgated under sub. (4) (c), an absentee ballot received from a military or overseas elector who receives the ballot electronically shall not be counted unless it is cast in the manner prescribed in this paragraph and sub. (4) (b) and in accordance with the instructions provided by the commission.




