PRELIMINARY DRAFT - NOT READY FOR INTRODUCTION

AN ACT ...; relating to: requiring the University of Wisconsin-Madison to conduct a research study on developing an agricultural science and technology

Analysis by the Legislative Reference Bureau

This bill requires the University of Wisconsin-Madison to conduct a research study on developing a science and technology program specific to agriculture. Such a program must include 1) curriculum that includes enhanced farming practices; and 2) coordination between the UW-Madison program and agricultural programs at other UW schools. A report that includes UW-Madison's findings, conclusions, and recommendations resulting from the study must be submitted to the legislature by approximately nine months after the bill's effective date.

For further information see the *state* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
