Robby:

How do you want to make the \$440,000 available: 1) one-time funding that has to be used up in the current biennium; 2) one-time funding, but it can be used up in current or future biennia; 3) on-going funding of \$440,000 for each fiscal year; or 4) on-going funding of \$440,000 for each fiscal biennia?

Also I can either: 1) require the Board of Regents to allocate that amount from its big GPR appropriation or 2) create a new appropriation that is dedicated only to that purpose. If it's a one-time amount limited to current fiscal biennia, I'd go with the first option, but you do either option for an on-going amount.
