SENATE ASSEMBLY AMENDMENT,

TO ASSEMBLY BILL 3770 SENATE 347

At the locations indicated, amend the bill as follows:

- 1. Page 1, line 4: after "POLICY" insert "AND INSTRUCTIONAL PROGRAM".
- **2.** Page 1, line 5: delete "prepare," and substitute "develop,".
- 3. Page 2, line 1: delete the material beginning with "and develop" and ending with "curriculum" on line 4.
 - **4.** Page 2, line 4: after that line insert:
 - "(ag) By July 1, 2020, develop and make available to each school district an instructional program appropriate for pupils in kindergarten to grade 6 that includes the instruction required under s. 118.018 (2). The state superintendent shall incorporate the instructional program into its model health problems education curriculum.
 - (am) In developing the model policy under par. (a) and the instructional program under par. (ag), consult with state and local experts in child sexual abuse

 - 2. Anatomically correct terms for body parts.
 - 3. How to say no and reject unwanted advances.
 - 4. How to set and respect personal boundaries.
- 5. Differences between public and private parts of the body.
- 7. Autonomy over decision-making related to the body, empowerment, and developing assertiveness skills.
- 8. How to distinguish between safe and unsafe touch and between secrets and surprises.
- 9. How to identify trustworthy adults.
