45.41 Payments to veterans organizations.

- (1) In this section:
- (a) "Regional office" means the U.S. department of veterans affairs regional office in Wisconsin.
- (b) "State veterans organization" means the state organization or department of a national veterans organization incorporated by an act of congress.

(2)

- (am) Upon application the department may make a payment to any state veterans organization that establishes that it, or its national organization, or both, has maintained a full-time service office at the regional office for 5 consecutive years out of the 10-year period immediately preceding the application. Any payment shall be calculated based on the total amount of all salaries and travel expenses under sub. (3) paid during the previous fiscal year by the state veterans organization to employees engaged in veterans claims service and stationed at the regional office. The department shall pay an amount equal to 50 percent of all salaries and travel expenses under sub. (3) or \$100,000175,000, whichever is less, to a recipient under this paragraph.
- (e) An organization that receives a payment under par. (am) shall maintain records as required by the department concerning the organization's expenditure of the payment. That organization shall give the department access to those records upon request of the department, and the department may audit those records.
- (3) A state veterans organization shall file an application annually with the department for the previous 12-month period ending on March 31 of the year in which it is filed. The application shall contain a statement of salaries and travel expenses paid to employees of the organization engaged in veterans claims service activities at the regional office by the state veterans organization covering the period for which application for a payment is made. The statement shall be certified as correct by a certified public accountant licensed or certified under ch. 442 and sworn to as correct by the adjutant or principal officer of the state veterans organization. The application shall include the state organization's financial statement for its previous fiscal year and evidence of claims service activity that the department requires. The state veterans organization shall submit with its initial application sufficient evidence to establish that it or its national organization, or both, has maintained a full-time service office at the regional office for 5 consecutive years out of the 10-year period immediately preceding the application. Subsequent applications shall be accompanied by an affidavit by the adjutant or principal officer of the state veterans organization stating that the organization, on its own or with its national organization, maintained a full-time service office at the regional office for the entire 12-month period for which application for a payment is made.
- (3m) If the total amount of payments committed to be paid under sub. (2) (am) exceeds the amount available for the payments from the appropriation under s. 20.485 (2) (vw), the department shall prorate the reimbursement payments among the state veterans organizations receiving the payments.

(4)

- (a) From the appropriation under s. <u>20.485 (2) (s)</u>, the department shall annually provide a payment of \$200,000 to the Wisconsin department of the Disabled American Veterans for the provision of transportation services to veterans.
- (b) The Wisconsin department of the Disabled American Veterans shall maintain records as required by the department concerning its expenditure of the payment under par. (a). The Wisconsin department of the Disabled American Veterans shall give the department access to those records upon request of the department and the department may audit those records to ensure that the Wisconsin department of the Disabled American Veterans is using the payment under par. (a) to provide transportation services to veterans.
- (5) From the appropriation under s. 20.485 (2) (vs), the department may annually grant up to \$75,000 to the Wisconsin department of the American Legion for the operation of Camp American Legion.

SUBJECT: Activity Report, January - April 2019

January – I attended to duties at the Mid-Winter Conference meetings (and the awesome concert). We represented two veterans in video conferences for the Board of Veterans Appeals (BVA) and one local hearing at the Regional Office, Milwaukee, WI. Attended Veteran Hospital (VAMC) and VA Regional Office (VARO) meetings.

February – We represented three veterans in BVA hearings at the VARO. I attended VAMC and VARO meetings. I attended Department Service Officer School and National Conference in Washington, DC. Bergmann & Moore (B&M), the new law firm has continued our training. As I have said before, the training was not to the same as the National Veteran Legal Service Program (NVLSP). They still do not have two tiers of classes as did the NVLSP. One for beginners and one for seasoned DSOs. Change is usually wrought with negativity, so I will concentrate on the positive aspects of the new format. B&M are getting better with our (Mine and fellow DSOs) suggestions and covered some court cases and law changes. Their approach has seasoned and new service officers and representatives (reps) sitting together as a team. This cultivates a mentorship environment. This helps the newer reps through the class and creates a cohesive team feeling. Since the teams change each training, the networking is increased. At the meetings, the BVA informed us that in the future, they will be scheduling BVA hearings.

March – Surprisingly, we had no local hearing BVA hearings this month. I attended VAMC and VARO meetings.

April – Submitted Service Office data required to submit WDVA Grant Request. We represented two veterans at BVA hearings in the Regional Office. We represented two veterans at local VARO hearings. The BVA scheduling change has started to cause problems. We have been unsuccessful at making changes to accommodate veterans that were easily handled when the VARO did the scheduling. An example would be creating a three-way video hearing between VARO Minneapolis, VARO Milwaukee, and the BVA in Washington, DC for a veteran who lives near Minneapolis in Wisconsin. Our requests were seemingly ignored. The veteran could not make the four plus hour drive and therefore, had to cancel his hearing.

The ongoing Veterans Benefits Administration transformation continues pressing for digital submission of claim paperwork. This is changing the way we track workload data.

Definitions

Burial Benefits – Includes plot and internment allowances and in some cases transportation. **Compensation** – Payments related to service connected disabilities.

Pension — Payments to wartime veterans or their surviving spouse who meet net worth, income, service and disability requirements.

DIC – Dependent Indemnity Compensation – Payments to a deceased veteran's spouse, if the spouse meets marriage longevity requirements, for the death of the veteran due to active duty or a service connected disability or for a death of a veteran who was rated 100% or TDIU for the required period of 1, 5 or 10 years depending on veteran's qualifying status.

Education – Includes active duty, reserve and dependent education benefits.

Vocational Rehabilitation – Home adaptation, education and training benefits for veterans who due to their service connected disability need training and education to become employable.

Automobile – A special allowance to help purchase a vehicle afforded severely disabled veterans. This vehicle is then adapted to the transportation or driving needs of the veteran.

Whether I am the speaking at a veteran's center at a collage or simply walking in a parade, I enjoy representing The American Legion. Your Service Office is honored to represent The American Legion, Department of Wisconsin. Your office is proud, knowing that veterans, war widows(ers) and orphans will receive their due benefits and possibly one day a college education because we were able to help. We are currently tracking 27,975 client files. Over the last 12 months, your Service Office assisted veterans and their families in attaining over 335 Million dollars in due benefits. To accomplish this, we completed over 81,000 total services including over 26,000 database client services, almost 42,500 processed pieces of mail, over 5,000 phone calls and assisted over 2,500 walk in clients. VA Benefits administered include education, vocational rehabilitation, burial, compensation, pension, death pension, dependent indemnity compensation, automobile allowance, and adaptation for automobile and home. * 2007 is the first year I was in the service office and is there for reference

Our office administers the National Level Children and Youth, Temporary Financial Assistance program (TFA), our Department Troop and Family Support (T&FS) Fund, and the Veterans Assistance Fund (VAF). Additionally, we speak at events, staff Veterans Benefit Supermarkets and Stand Downs around the state. We are in direct contact monthly with the Directors of the Milwaukee VA Medical Center and Regional Office. We are proud the word is finally getting out about the Radiation Exposure Compensation Act (RECA). I am still filing claims and I have fielded many questions on the subject. The Service Office received the WDVA Grant of \$100,000.

NOTE: The ongoing Veterans Benefits Administration transformation to digital submission of claim paperwork is changing the way we will track workload data in 2018. We have gone to digital processing of ratings, awards, and receipts from CVSOs (thanks again to Maynard for the hard work). These changes are focused on the reduction of office supplies cost and streamlining the process, lowering workload intensity. Look for more changes to come.

October – Attended Department Fall Committee meetings and submitted report to the DEC. Attended monthly VARO and VAMC Service Officer Meetings. I was once again requested to represent the Veteran Service Organizations while training the new VA Hospital Social Workers. We provided services at a Veterans event in Milwaukee. Represented two veterans at their hearings at the VA Regional Office Milwaukee and one veteran at their Board of Veteran Appeals Video Board hearings at the VA Regional Office Milwaukee.

November – Attended American Legion tour of the Chippewa Falls WDVA Veterans Home and a meeting with the Commandant. Provided services at UW Green Bay at a veteran's event. Represented two veterans at their hearings at the VA Regional Office Milwaukee. I continue to be a VARO fire marshal. Attended monthly VARO and VAMC Service Officer meetings. Represented two veterans at their Board of Veteran Appeals Travel Board hearings at the VA Regional Office Milwaukee.

December – Attended American Legion tour of the Milwaukee VA Medical Center and a meeting with the Director. Attended monthly VARO and VAMC Service Officer Meetings. 
