(1) **BUDGET DEADLINE EXTENDED.** The deadline of Tuesday, January 29, 2019, set by section 16.45 of the statutes for introduction of the executive budget bill or bills, submittal of the state budget report, and delivery of the governor's budget message, is extended to Thursday, February 28, 2019.
