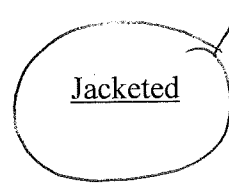

This joint resolution modifies the session schedule of the legislature to extend the deadline for the governor's budget message until February 26, 2019.

3 **SECTION 1. 2019-2020 session schedule modified.** The session schedule of
4 the legislature set forth by 2019 Senate Joint Resolution 1 is modified as follows:

6 (1) BUDGET DEADLINE EXTENDED. The deadline of Tuesday, January 29, 2019, set
7 by section 16.45 of the statutes for introduction of the executive budget bill or bills,
8 submittal of the state budget report, and delivery of the governor's budget message,
9 is extended to Tuesday, February 26, 2019.
