Thank you all for agreeing to co-author the Wisconsin Personhood Amendment! I am excited about the new language, the opportunity to attract new co-sponsors, and a public hearing. Thank you Joe!

Please see attached a draft PLW legislative memo that will follow your co-sponsorship memo. Andre has agreed to lead in the drafting of the cosponsorship memo, and I recommend Joe and Janel lead in responding to the press. I will certainly field the press calls to PLW. I am working on talking points for all of us. Please also see attached Personhood Alliance President Gualberto Garcia Jones' informal legal analysis of LRB 4208/P2.

I recommend you send the co-sponsorship memo on January 2 or 3 (or no later than January 6 or 7) and schedule a hearing in Assembly Health in early or mid-February at the latest. Gualberto Garcia Jones can testify at the hearing in early or mid-February. He will keep his calendar open for that time frame, and we will fly him in to Madison from D.C.
