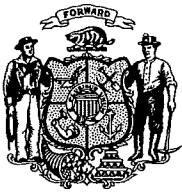

Based on some updated information we have received, could you update the draft to specify that DOA may not award TEACH grants that total more than \$3 million annually in FY20 and FY21. The department can still award up to \$7.5 million in grants during FY19. Could you also specify that DOA may not award grants after June 30, 2021 (as opposed to July 1)?
