In the children and family aids draft (19-1909_P1), please change the amounts to \$78,521,500 in FY20 and \$90,291,800 in FY21.

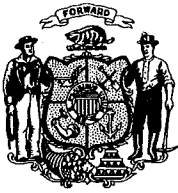
