Hi Matthew,

We spoke with our legal counsel this morning on the issue of the hybrid vehicle definition. They suggested that we define the intent of our statutory fix but let LRB draft the actual stat language.

As such, the intent of making this stat fix is to allow DMV to collect the \$75 surcharge on hybrid vehicles. Currently DMV cannot collect the surcharge because of the reference to battery size. Battery size is not a piece of information that can be gained from a VIN, which is what DMV uses to identify vehicles for registration purposes. DMV can use the fuel type indicator (both primary and secondary) provided by a vehicle's VIN to identify hybrid vehicles, see below for a screenshot of a Prius VIN decoded on the NHTSA VIN decoder:
