LRB-1934: An update to 49.175(1)(f) will be needed. The additional \$500,000 TANF money in this allocation should be directed to be transferred to JFC's supplemental PR appropriation (20.865(4)(g)) instead of for grants under 16.3085/20.505(7)(kg).

[LFB Paper #115 -- Substitute Alternative]

Motion:

Move to provide \$3,250,000 GPR and \$500,000 PR annually to the Committee's GPR and PR supplemental appropriations for homelessness prevention initiatives.

Note:

The Department of Administration oversees the Wisconsin Interagency Council on Homelessness, created under 2017 Act 74 to establish and coordinate the implementation of statewide policies on homelessness. In November, 2018, the Interagency Council published a 2019 to 2022 statewide action plan with policy recommendations to prevent and end homelessness in Wisconsin.

Under this motion, the Committee would place funding associated with the fiscal recommendations identified in the Council's plan into the Committee's supplemental appropriations for potential utilization.

[Change to Base: \$6,500,000 GPR and \$1,000,000 PR]

[Change to Bill: -1.00 GPR position, \$268,000 FED and 2.00 FED positions, and -\$134,000 PR and -1.00 PR position]

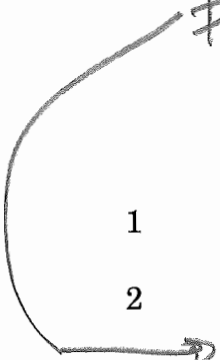
