Analysis by the Legislative Reference Bureau

This bill requires the Department of Workforce Development to award grants of \$75,000 per year of the 2019-21 fiscal biennium under its workforce training program, commonly referred to as the Fast Forward Program, to the Northcentral Technical College for workforce training in county jail facilities.

For further information see the ***state and local*** fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 **SECTION 9150. Nonstatutory provisions; Workforce Development.**
4 **(1) GRANTS TO NORTHCENTRAL TECHNICAL COLLEGE FOR WORKFORCE TRAINING IN**
