22 care workers under s. 48.685. Notwithstanding s. 227.24 (1) (c) and (2), emergency
23 rules promulgated under this subsection remain in effect until January 1, 2022, or
24 the date on which permanent rules take effect, whichever is sooner.
25 Notwithstanding s. 227.24 (1) (a) and (3), the department is not required to provide

1 evidence that promulgating a rule under this subsection as an emergency rule is
2 necessary for the preservation of the public peace, health, safety, or welfare and is
3 not required to provide a finding of emergency for a rule promulgated under this
4 subsection.

5 (2) BACKGROUND CHECKS FOR CONGREGATE CARE WORKERS. No later than the first
6 day of the 7th month beginning after the effective date of this subsection, the
7 department of children and families, the county department as defined in s. 48.02
8 (2g), the child welfare agency, or the congregate care facility as defined in s. 48.685
9 (1) (ao) shall perform a comprehensive background check as required by s. 48.685 (2)
10 for all congregate care workers, as defined in s. 48.685 (1) (ap), who are working at

20 (2) **MEDICAL ASSISTANCE REIMBURSEMENT FOR SERVICES PROVIDED THROUGH**
21 **TELEHEALTH.** The department of health services shall develop, by rule, a method of
22 reimbursing providers under the Medical Assistance program for a service that is
23 covered by the Medical Assistance program under subch. IV of ch. 49 and that
24 satisfies any of the following:

1 (a) The service is a consultation between a provider at an originating site and
2 a provider at a remote location using a combination of interactive video, audio, and
3 externally acquired images through a networking environment.

4 (b) The service is an asynchronous transmission of digital clinical information
5 through a secure electronic system from a Medical Assistance recipient or provider
6 to a provider.

7 (3p) FOODSHARE EMPLOYMENT AND TRAINING PROGRAM REPORT AND FUNDING. To
8 obtain supplemental funding from the appropriation under s. 20.865 (4) (a), the
9 department of health services shall submit under s. 13.10 after April 1, 2020, a
10 request to the joint committee on finance that contains a report on enrollment of
11 able-bodied adults in the food stamp program's employment and training program
12 between October 1, 2019, and March 31, 2020, to justify the request. The joint
13 committee on finance may supplement the appropriation under s. 20.435 (4) (bp)
14 from the appropriation under s. 20.865 (4) (a) if the joint committee on finance
15 approves the request under this subsection. Notwithstanding s. 13.101 (3), the joint
16 committee on finance may make a supplementation under this subsection without
17 finding that an emergency exists.

18 (6) EVIDENCE-BASED ORAL HEALTH GRANTS AND SEAL-A-SMILE PROGRAM.
19 Notwithstanding s. 250.10 (1m) (b), in fiscal year 2019-20, the department of health
20 services shall, from the appropriation under s. 20.435 (1) (de), award to qualified
21 applicants grants totaling \$50,000 for fluoride varnish and other evidence-based
22 oral health activities, \$525,000 for school-based preventive dental services, and
23 \$100,000 for school-based restorative dental services.

24 (6f) SUICIDE PREVENTION GRANT. From the appropriation under s. 20.435 (5) (bc),
25 the department of health services shall award to the Wisconsin United Coalition of

1 Mutual Assistance Association, Inc., a onetime grant in the amount of \$100,000 in

9 Medical Assistance payments, and the matching federal share of payments. In fiscal
10 year 2020-21 only, the department of health services shall pay to hospitals that serve
11 a disproportionate share of low-income patients an additional \$30,000,000 to the
12 amount under s. 49.45 (3m) (a) (intro.), as the state share of Medical Assistance
13 payments, and the matching federal share of payments.

14 (b) In fiscal year 2019-20 only, the maximum disproportionate share hospital
15 payment under s. 49.45 (3m) (b) 3. a. for any single hospital is \$9,600,000. In fiscal
16 year 2020-21 only, the maximum disproportionate share hospital payment under s.

22 annual rate increase related to an increase in acuity of patients in those facilities;
23 by a budgeted sum of \$15,000,000, as the state share of payments, and the matching

1 state share of payments, and the matching federal share of payments, in 2020-21,

7 deer farm in the southern part of the state where chronic wasting disease was

25 of having received matching funds from nongovernmental sources in an amount

1 equal to the amount of the grant award. No later than July 1, 2021, the Lakeland
2 Union High School school district shall provide to the legislature and the department
3 a report in the manner provided under s. 13.172 (2) describing the use of grant
4 moneys received under this subsection.

24 eligibility criteria under s. 85.095, the department of transportation shall give

1 priority to municipalities in which a shipbuilder in this state is conducting
2 operations.

3 (3) STATEWIDE PUBLIC SAFETY INTEROPERABLE COMMUNICATIONS SYSTEM. No later
4 than June 30, 2020, the department of transportation, in collaboration with the
5 department of military affairs, shall issue a request for proposals for a statewide
6 public safety interoperable communications system to be deployed on existing tower
7 sites. The department of transportation may expend not more than \$500,000 to enter
8 into a contract with an organization to provide professional consulting services
9 related to development of bidder qualifications and technical requirements for the
10 request for proposals issued under this subsection.

11 (4e) NOISE BARRIER ON I 41. The department of transportation, during the
12 2019-21 fiscal biennium, shall install a noise barrier along the east side of I 41
13 adjacent to 112th Street, between Clarke Street and Center Street, in Milwaukee

20 department of transportation expends from the state patrol's general operations
21 appropriation accounts during the 2019-21 fiscal biennium for the security and
22 safety of the lieutenant governor may not exceed the amount expended by the
23 department of transportation from the same appropriation accounts during the
24 2017-19 fiscal biennium for the same purpose.

1 (4p) EMERGENCY RULES RELATING TO ALTERNATIVE PROJECT DELIVERY. The
2 department of transportation may use the procedure under s. 227.24 to promulgate
3 emergency rules under s. 84.062 (5) to (7) for the period before the date on which
4 permanent rules under s. 84.062 (5) to (7) take effect. Notwithstanding s. 227.24 (1)
5 (c) and (2), emergency rules promulgated under this subsection remain in effect until
6 the first day of the 25th month beginning after the effective date of the emergency
7 rule, the date on which the permanent rules take effect, of the effective date of the
8 repeal of the emergency rule, whichever is earlier. Notwithstanding s. 227.24 (1) (a)
9 and (3), the department of transportation is not required to provide evidence that
10 promulgating a rule under this subsection as emergency rules is necessary for the
11 preservation of public peace, health, safety, or welfare and is not required to provide
12 a finding of emergency for a rule promulgated under this subsection.

13 (4q) EMPLOYEES OF THE OFFICE OF INNOVATIVE PROGRAM DELIVERY. The secretary
14 of the department of transportation shall assign from the department's existing
15 position authority at least 1.0 FTE position to the office of innovative program
16 delivery attached to the department of transportation.

17 (4x) CITY OF KAUKAUNA BRIDGE. Notwithstanding s. 84.18 (4) and (5), in the
18 2019-21 fiscal biennium, from the appropriation under s. 20.395 (2) (eq), the
19 department of transportation shall provide funds to the city of Kaukauna for the
20 rehabilitation of the Veterans Memorial Bridge on Catherine Street in the city of
21 Kaukauna, including the repair or replacement of the lifting mechanism of the
22 bridge. The department shall provide the same percentage of the cost of the Veterans
23 Memorial Bridge rehabilitation as the percent established under 23 USC 144 (f) (2).
24 Notwithstanding s. 84.18 (6), the department may not establish a limit on eligible

2 appropriation account under s. 20.192 (1) (r), the Wisconsin Economic Development
3 Corporation shall grant \$250,000 to the Milwaukee 7 Economic Development
4 Partnership in the 2019-20 fiscal year for supporting efforts by the 128th Air
5 Refueling Wing of the Wisconsin air national guard to secure basing of the U.S. air
6 force's KC-46 tanker aircraft.
