A bicycle, motor bicycle, $\mathbf{2}$ personal delivery device, electric scooter, or electric personal assistive mobility 3 device shall also be equipped with a red reflector that has a diameter of at least 2 4 inches of surface area or, with respect to an electric scooter or an electric personal 5 assistive mobility device, that is a strip of reflective tape that has at least 2 square inches of surface area, on the rear so mounted and maintained as to be visible from 6 7 all distances from 50 to 500 feet to the rear when directly in front of lawful upper 8 beams of headlamps on a motor vehicle. A lamp emitting a steady or flashing red 9 light visible from a distance of 500 feet to the rear may be used in lieu of the red 10 reflector.
