4	(a); and <i>to create</i> 340.01 (15ph), 346.806, 347.02 (1) (em), 347.489 (3m) and
5	349.18 (4) of the statutes; relating to: electric bicycles and providing a penalty.

Analysis by the Legislative Reference Bureau

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 23.335 (1) (q) of the statutes is amended to read:
23.335 (1) (q) "Off-highway motorcycle" means a 2-wheeled motor vehicle that
is straddled by the operator, that is equipped with handlebars, and that is designed
for use off a highway, regardless of whether it is also designed for use on a highway.
<u>"Off-highway motorcycle" does not include an electric bicycle, as defined under s.</u>
<u>340.01 (15ph).</u>

1	SECTION 2. 70.111 (1) of the statutes is amended to read:
2	70.111 (1) JEWELRY, HOUSEHOLD FURNISHINGS, AND APPAREL. Personal ornaments
3	and jewelry, family portraits, private libraries, musical instruments other than
4	pianos, radio equipment, household furniture, equipment and furnishings, apparel,
5	motor bicycles, <u>electric bicycles</u> , bicycles, and firearms if such items are kept for
6	personal use by the owner and pianos if they are located in a residence.
7	SECTION 3. 194.01 (7) of the statutes, as affected by 2019 Wisconsin Act 11, is
8	amended to read:
9	194.01 (7) "Motor vehicle" means any automobile, truck, trailer, semitrailer,
10	tractor, motor bus, or any self-propelled or motor driven vehicle, except a motorcycle,
11	moped, motor bicycle, <u>electric bicycle</u> , electric scooter, electric personal assistive
12	mobility device, personal delivery device, or vehicle operated on rails.
13	SECTION 4. 340.01 (15ph) of the statutes is created to read:
14	340.01 (15ph) "Electric bicycle" means a bicycle that is equipped with fully
15	operative pedals for propulsion by human power and an electric motor of 750 watts
16	or less and that meets the requirements of any of the following classifications:
17	(a) Class 1 electric bicycle is an electric bicycle equipped with a motor that
18	provides assistance only when the rider is pedaling and that ceases to provide
19	assistance when the bicycle reaches the speed of 20 miles per hour.
20	(b) Class 2 electric bicycle is an electric bicycle that may be powered solely by
21	the motor and is not capable of providing assistance when the bicycle reaches the
22	speed of 20 miles per hour.
23	(c) Class 3 electric bicycle is an electric bicycle equipped with a motor that
24	provides assistance only when the rider is pedaling and that ceases to provide
25	assistance when the bicycle reaches the speed of 28 miles per hour.

2	340.01 (29m) (bm) "Moped" does not include a motor bicycle <u>or electric bicycle</u> .
3	SECTION 6. 340.01 (30) (intro.) and (a) of the statutes are consolidated,
4	renumbered 340.01 (30) and amended to read:
5	340.01 (30) "Motor bicycle" means any of the following: (a) A <u>a</u> bicycle to which
6	a power unit <u>that is</u> not an integral part of the vehicle has been added to permit the
7	vehicle to travel at a speed of not more than 30 miles per hour with a 150-pound rider

14	more vehicles or an articulated vehicle, which is self-propelled, except a vehicle
15	operated exclusively on a rail. "Motor vehicle" includes, without limitation, a
16	commercial motor vehicle or a vehicle which is propelled by electric power obtained
17	from overhead trolley wires but not operated on rails. A snowmobile, an all-terrain
18	vehicle, a utility terrain vehicle, an electric scooter, and an electric personal assistive
19	mobility device shall be considered motor vehicles only for purposes made
20	specifically applicable by statute. <u>"Motor vehicle" does not include an electric bicycle.</u>
21	SECTION 9. $340.01 (74p) (c)$ of the statutes, as affected by 2019 Wisconsin Act
22	11, is amended to read:
23	340.01 (74p) (c) An operator of a moped, electric scooter, <u>electric bicycle</u> , or

3 SECTION 11. 346.02 (4) (title) of the statutes is amended to read:
4 346.02 (4) (title) APPLICABILITY TO PERSONS RIDING BICYCLES, ELECTRIC BICYCLES,
5 AND MOTOR BICYCLES.

6 SECTION 12. 346.02 (4) (a) of the statutes is amended to read:

7346.02 (4) (a) Subject to the special provisions applicable to bicycles, every8person riding a bicycle upon a roadway or shoulder of a highway is granted all the9rights and is subject to all the duties which that this chapter grants or applies to the10operator of a vehicle, except those provisions which that by their express terms apply11only to motor vehicles or which that by their very nature would have no application12to bicycles. For purposes of this chapter, provisions which that apply to bicycles also13apply to electric bicycles and motor bicycles, except as otherwise expressly provided.

SECTION 13. 346.806 of the statutes is created to read:

15 346.806 Special rules applicable to electric bicycles. (1) Except as 16 otherwise expressly provided, an electric bicycle and an operator of an electric bicycle 17 shall be afforded all the same rights and privileges, and be subject to the same duties, 18 provided in chs. 340 to 351 as a bicycle or an operator of a bicycle. An electric bicycle 19 shall be considered a vehicle to the same extent as a bicycle.

(2) A person operating an electric bicycle is not subject to the provisions under
ch. 341, 342, 343, or 344 relating to financial responsibility, operator's licenses,
registration, or certificates of title.

(3) (a) A person may ride, with the power unit in operation, an electric bicycle
upon a bikeway, as defined under s. 84.60 (1) (a), under the jurisdiction of the
department of natural resources, subject to any restrictions specified in a rule

1	promulgated by the department of natural resources under s. 349.18 (4) (b), or under
2	the jurisdiction of a municipality or county, subject to any restrictions specified in an
3	ordinance enacted under s. 349.18 (4) (a).
4	(b) A person may ride, with the power unit in operation, an electric bicycle upon
5	a bikeway, as defined under s. 84.60 (1) (a), under the jurisdiction of the department,
6	subject to any restrictions specified in a rule promulgated by the department.
7	(4) No person under the age of 16 years may operate a class 3 electric bicycle.
8	A person under the age of 16 years may ride as a passenger on a class 3 electric bicycle
9	that is designed to accommodate passengers.
10	SECTION 14. 347.02 (1) (em) of the statutes is created to read:
11	347.02 (1) (em) Electric bicycles.
12	SECTION 15. 347.489 (3m) of the statutes is created to read:
13	347.489 (3m) (a) 1. After January 1, 2018, a manufacturer or distributor of
14	electric bicycles shall permanently affix to the electric bicycle a label containing all
15	of the following information in Arial font of a minimum size of 9 point:
16	a. The classification number of the electric bicycle.
17	b. The speed at which the motor will cease to provide assistance or power.
18	c. The wattage of the motor equipped to the electric bicycle.
19	2. If a person modifies an electric bicycle so as to change the classification of
20	the electric bicycle, the person shall prepare and affix to the electric bicycle a revised
21	label satisfying the requirements of subd. 1.
22	(b) An electric bicycle shall meet the requirements of 16 CFR Part 1512, as if
23	the electric bicycle were a bicycle as defined under 16 CFR 1512.2 (a).

1	(c) An electric bicycle shall operate so that the motor ceases to provide
2	assistance or power when the brakes are applied or the motor ceases to provide
3	assistance or power when the rider stops pedaling.
4	(d) No person may operate a class 3 electric bicycle unless the electric bicycle
5	is equipped with a speedometer that with reasonable accuracy registers the speed
6	of the electric bicycle in miles per hour.
7	SECTION 16. 349.18 (4) of the statutes is created to read:
8	349.18(4)(a) The governing body of a municipality or county may by ordinance
9	prohibit the operation, with the power unit in operation, of electric bicycles on
10	bikeways, as defined under s. 84.60 (1) (a), under its jurisdiction.
11	(b) The department of natural resources may promulgate rules prohibiting the
12	operation, with the power unit in operation, of electric bicycles on bikeways, as
13	defined under s. 84.60 (1) (a), under its jurisdiction.
