**SENATE AMENDMENT 1,
TO SENATE BILL 34**

September 23, 2019 - Offered by Senator DARLING.

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 2, line 9: delete "**Civil**" and substitute "**Negligent hiring**".
- 3 **2.** Page 3, line 2: delete the material beginning with "for the acts" and ending
- 4 with "of the employee" on line 3 and substitute "in any proceeding on a claim against
- 5 the employer for negligent hiring of that employee".
