Good Afternoon Senator Jacque,

I have a question about the request regarding the YA programs and expanding the career clusters. The following is a list of the current career clusters available through a national non-profit that represents State Directors and state leaders responsible for secondary, postsecondary and adult Career Technical Education (CTE) across all 50 states and U.S. territories. Based on a review of the DWD website, they have only approved the career clusters that are in green (11).

Agriculture, Food & Natural Resources
Architecture & Construction
Arts, A/V Technology & Communications
Business Management & Administration
Education & Training
Finance
Government & Public Administration
Health Science
Hospitality & Tourism
Human Services
Information Technology
Law, Public Safety, Corrections & Security

Science, Technology, Engineering & Mathematics
Transportation, Distribution & Logistics

My question is: would you like to require that DWD include all of the career clusters ("occupations" in the statutes) in the list it approves for YA, or just the four that your local Chambers of Commerce are interested in? Right now, there is no explicit requirement in the statutes that the highlighted career clusters be the ones approved by DWD. In other words, DWD has been able to determine which ones to approve without any requirements.

The relevant statute, I believe, is s. 106.13 (2m):

“The department shall approve occupations and maintain a list of approved occupations for the youth apprenticeship program. From the appropriation under s. 20.445 (1) (a), the department shall develop curricula for youth apprenticeship programs for occupations approved under this subsection.”
