**Assumptions Used in Arriving at Fiscal Estimate**

This bill eliminates initial license fees for veterinary licenses and veterinary technician certificates.

In calendar year 2017, there were 193 initial veterinary licenses issued and 201 initial veterinary technician certificates issued. In calendar year 2018 there were 219 initial veterinary licenses issued and 214 initial veterinary technician certificates issued. Estimated revenue from calendar years 2017 and 2018 for initial licenses and certifications total approximately \$116,000, or on average \$58,000 annually. This bill would decrease revenues by approximately \$58,000 annually.
