Assumptions Used in Arriving at Fiscal Estimate

This bill creates new laws that limit the use of physical restraints on pregnant and postpartum people who are in the custody of a correctional facility, which includes state prisons, county jails, municipal lockups, juvenile correctional facilities, or juvenile detention facilities. This bill also requires that every woman in the custody of a correctional facility be offered testing for pregnancy and, if pregnant, be offered testing for sexually transmitted infections. Finally, this bill requires that the correctional facility where the pregnant or postpartum person is being confined provides information and access to health services related to pregnancy, labor, and the postpartum period.

The Department of Corrections (DOC) is unable to estimate the state fiscal impact of this bill since the security and health needs of inmate patients are very individualized. However, the DOC has policies in line with many of the provisions of this bill, so the fiscal impact is anticipated to be minimal. It should be noted, however, that any reduction in flexible security options available to the DOC may result in an increase in staff costs through overtime or through hiring limited term employees (LTEs) to provide additional security.

DOC administrative code requires jails to have policies and procedures for pregnancy management, but does not specify any additional criteria. Jails have complete discretion in determining what their policies will be. To that end, some jails may already have policies in place that are similar to the provisions of this bill. Others, however, may need to change their policies in order to be compliant with this bill. The local fiscal impact is ultimately indeterminate because the costs may vary among the counties and municipalities depending on the amount of change needed to be compliant with this bill.
