### Assumptions Used in Arriving at Fiscal Estimate

This bill expands the acts for which a juvenile may be placed in the Serious Juvenile Offender Program (SJOP). This bill also allows certain acts to count as evidence of dangerousness to justify placement in a juvenile correctional facility or secured residential care center for children and youth under the Juvenile Justice Code.

The bill does not change any funding or formulas in chapter 20 or other statutes. There would be no costs to DCF related to this bill.

Department of Corrections (DOC) pays the costs of placements in the SJOP, including confinement in a juvenile correctional facility and supervision post-release. Costs for non-SJO correctional placements and aftercare are paid by counties. This means that costs could shift from counties to DOC. The amount is indeterminate.
