Assumptions Used in Arriving at Fiscal Estimate

This bill would amend 230.35 (4) (c) and 995.20; and create 230.35 (4) (a) 5m to establish a legal holiday known as Democracy Day and closing state offices on the Tuesday after the first Monday in November in honor of veterans and their effort to protect our democracy, liberties, and freedoms, especially the right to vote.

This bill will not have a fiscal impact on the University of Wisconsin (UW) System because UW is no longer governed by Wis. Stat. 230 for leave benefits. However, if this bill is passed, UW would likely review its leave policies to determine if it would want to align with other state agencies in this regard.
