 \*\*\*\*NOTE: Corrects nonsubstantive discrepancies between the amendment of s. 118.60 (2)(a) 8., in SECTION 1 of the bill, and s. 119 (2)(a) 8., in SECTION 2 of the bill. The amended statutes are exact parallels, and the scored-in language should have been exactly parallel.
