Assumptions Used in Arriving at Fiscal Estimate

Under current law, veterans are eligible for a fee waiver for a variety of state-issued licenses and certifications. This bill expands eligibility to include the spouse of any veteran included in the current fee waiver program. The Department of Veterans Affairs does not issue any licenses or certifications relating to this bill. The only role the Department plays in licensing and certification is to verify whether an applicant is eligible for a fee waiver. This Bill will have no fiscal effect on the Department of Veterans Affairs.
