## Assumptions Used in Arriving at Fiscal Estimate

The bill requires the department to make dog training licenses available for purchase via Go Wild.

- I. Assumptions and Background Information
- A. The current dog training license application process requires a completed paper application form be mailed to the department or brought to an open Service Center for processing. Property managers review applications for hound dog training licenses and dog club licenses and receive payment of fees. Service Center Customer Service staff are authorized to accept and approve bird dog training applications if complete and submitted with the required fee.
- B. The bird dog training license is a product that is generally available to all applicants after the required information is provided and appropriate fee paid. Property manager review is not required to issue a bird dog training license and as such, the bird dog training license could be configured so that it was immediately available for purchase within Go Wild after the required information was submitted and fee paid.
- C. The department would continue to require hard copy paper applications for hound dog and club dog training licenses to be mailed to the department so that property managers may continue to review the applications. If the application is approved, the "authority to purchase" the license would be placed on the applicant's Go Wild account. The "authority to purchase" would allow the customer to make payment for the hound dog or dog club training license via their Go Wild account. Approved customers could purchase on-line or at any authorized DNR agent.
- II. Fiscal Effect
- A. Revenue no impacts to revenue are expected. Making dog training licenses available for purchase in Go Wild and possibly accessible via the Conservation Card is not expected to increase number of dog training licenses issued.
- B. One Time Costs
- 1. Product setup in Go Wild: 40 hours \* \$50/hr. (average business analyst rate plus applicable fringe) = \$2,000
- 2. Staff time to update Hound Dog and Dog Club Training License Application Form: 20 hours \* \$50/hour (average policy advisor rate plus applicable fringe) = \$1,000
- 3. Updating dog training web pages and Go Wild license agent resources: 40 hours development \* \$50/hour (average policy advisor rate plus applicable fringe) = \$2,000
- 4. Training Customer Service Representative (CSR) staff:
  [20 hours training development \* \$50/hour (average policy advisor rate plus applicable fringe)] + [1 hour \* 100 CSRs \* \$27.50/hour (average CSR rate plus fringe)] = \$3,750
- 5. Rule promulgation rulemaking to update NR 8.045 Forms of Proof, NR 17.01 Bird Dog Training Licenses, NR 17.02 Hound Dog Training Licenses, and NR 17.03 Dog Club Training Licenses: 160 hours \* \$50 (average policy advisor rate plus applicable fringe) = \$8,000
- 6. Total one time costs of \$16,750.
- C. Ongoing Costs

- 1. Additional ongoing transaction fees \$1.15 per transaction when license is only product in transaction. Total transaction fees would be less for transactions that contain other products. Total transaction fees would be ~\$500/yr., assuming 432 dog training licenses issued per year. Itemized costs are as follows:
- a. Vendor transaction fees department required to pay \$0.65 transaction fee to license system vendor for each Go Wild transaction per vendor contract: 432 dog training licenses \* \$0.65 = \$300
- b. Agent transaction fee department required to pay \$0.50 for each Go Wild transaction per 29.566(1m): 432 dog training licenses \* \$0.50 = \$200.
