Assumptions Used in Arriving at Fiscal Estimate

The bill requires an agency to promulgate rules describing how and when the agency will impose conditions on a license, permit, certificate, or other such approval that is granted by the agency. The agency must, under the bill, impose conditions on licenses in accordance with those rules.

Current law allows the governor, by executive order, to prescribe guidelines to ensure that rules are promulgated in accordance with the statutory rule-making process. The bill repeals this provision that allows the governor to prescribe such guidelines.

The changes made under this bill, as they affect DOR, do not have any state or local fiscal effects.

DOR does not currently impose any conditions on certification or permit grants or renewals that are not already specified in statute or rule, with the following exceptions:

- A) Excise audit/enforcement may require permit applicants to acquire and maintain a TTB permit
- B) Excise audit/enforcement may require permit applicants to resolve zoning issues, municipal objections, or DATCP/local health inspection issues prior to issuing a permit

Under the bill, DOR would promulgate rules for these items.
